This Voluntary Product Accessibility Template (VPAT) provides guidance on the accessibility characteristics of Citrix SCOM Management Packs as of 11/10/2017.

System Center Operations Manager (SCOM) management packs are rule sets intended to extend and configure SCOM for specific services or applications. After a management pack is installed, it appears as a series of folders in the SCOM navigation pane; the SCOM user interface is therefore used to access all these folders and the information that they display.

The current version of each **Citrix SCOM Management Pack** listed above was tested for conformance with Section 508 of the Rehabilitation Act, specifically the U.S. Access Board's Technical Requirements. This product was tested as of **November 10, 2017**, and is only valid for the version and date it was tested.

Assistive technology products used as part of testing included Freedom Scientific JAWS 18.0, AI Squared ZoomText 11, Inspect, Microsoft Windows accessibility features, and keyboard-only control.
